

## **PRIVACY POLICY**

Below, you will find the Privacy Policy for Oxbow Tourism LLC DBA: Pontoon Saloon – referenced in this articles here in as “Pontoon Saloon”, which applies to any information provided or collecting through this [www.PontoonSaloonTN.com](http://www.PontoonSaloonTN.com) website and/or any Pontoon Saloon application, all of which are owned and operated by Pontoon Saloon. We understand that booking online involves trust on your part, and we value your trust and make it a high priority to ensure the security and confidentiality of the personal information you provide to us. Please read this policy to learn about our privacy practices. By visiting this website, you are accepting the practices described herein. If you do not agree with the practices described in this policy, please do not use this website or submit your personal information to us.

### **WHAT INFO WE COLLECT FROM YOU.**

In General. We receive and store any information you enter on our website or give us in any other way. This includes information that can identify you (“personal information”), including your first and last name, telephone number, postal and email addresses and billing information (such as credit card number, cardholder name, and expiration date). You can choose not to provide information to us, but in general most of the information we request from you is required in order to reserve a booking complete, ask us a question, or initiate other transactions on our website.

Automatic Information. We automatically collect some information from your computer or Device when you visit Pontoon Saloon. For example, we will collect session data, including your IP address, Web browser software, and referring website.

### **HOW WE USE YOUR INFORMATION.**

We use sensitive billing information (such as cardholder name, credit card number, and expiration date) for the purpose of completing booking reservation you make on our website. We use other information about you for the following general purposes so long as you have given your consent; ; to communicate with you in general; to respond to your questions and comments; to enforce our Terms of Use; and as otherwise described to you at the point of collection.

Please review “Your choices with respect to the collection and use of your information” below.

### **WITH WHOM WE SHARE YOUR INFORMATION.**

Pontoon Saloon may share your information if we believe, in our sole discretion, that such disclosure is necessary...

- To comply with legitimate and enforceable subpoenas, court orders, or other legal process; to establish or exercise our legal rights; to defend against legal claims; or as otherwise required by law. In such cases we reserve the right to raise or waive any legal objection or right available to us
- To investigate, prevent, or take action regarding illegal or suspected illegal activities; to protect and defend the rights, property, or safety of Pontoon Saloon, our customers, or others; and in connection with our Terms of Use and other agreements
- In connection with a corporate transaction, such as a divestiture, merger, consolidation, or asset sale, or in the unlikely event of bankruptcy.

Other than as set out above, you will be notified when personal information about you will be shared with third parties, and you will have an opportunity to choose not to have us share such information.

We also may share aggregate or anonymous information with third parties, including advertisers and investors. For example, we may tell our advertisers the number of visitors our website receives. This information does not contain any personal information and is used to develop content and services we hope you will find of interest.

#### **HOW CAN YOU ACCESS YOUR INFORMATION.**

We take reasonable steps to ensure that your information is relevant to its intended use, accurate, and complete. You can access and update your contact information by visiting the Pontoon Saloon website. Please also note that we may retain certain information associated with your booking in archives, including for analytical purposes as well as for recordkeeping integrity.

#### **YOUR CHOICE WITH RESPECT TO THE COLLECTION AND USE OF YOUR INFORMATION.**

As discussed above, you can choose not to provide us with any information, although it may be needed to book your reservation on this website.

You can also add or update information and close your account as described above.

You have the opportunity on our website to provide a mobile number in order to receive your confirmation details.

#### **HOW WE PROTECT YOUR INFORMATION.**

We want you to feel confident about using Pontoon Saloon, and we are committed to protecting the information we collect. While no website can guarantee security, we have implemented appropriate administrative, technical, and physical security procedures to help protect the personal information you provide to us. For example, only authorized employees are permitted to access personal information, and they only may do so for permitted business functions. In addition, we use encryption when transmitting your personal information between your system and ours, and between our system and those of the parties with whom we share sensitive information, and we employ firewalls and intrusion detection systems to help prevent unauthorized persons from gaining access to your information.

#### **CHILDRENS PRIVACY.**
